Project development

From Danube Culture Dialogue to the Danube Culture Platform

- 2012: Founding of association Danube Cultural Cluster
- June/ July 2013: Development of project idea in coop. with unit EU Cultural Policy (Fed. Chancellery)
- Aug. 2013: Application for TAF – Technical Assistance Facility for Danube Region Projects
- Sept. 2013: Assignment of TAF
- Dec. 2013 – June 2014: Receiving TAF advisory services
- June 2014: Results

Next steps:

- Preparation for INTERREG VB Central Europe Programme application
- Development of a small project fund as a public – private partnership model
